<u>RESPONDENT LYNN HUBBARD'S MOTION IN LIMINE TO PRECLUDE ANY AND</u> <u>ALL EVIDENCE REGARDING THE \$5,000 CHECK TO RIVIERA BEACH</u> <u>PREPARATORY ACADEMY REFERENCED IN KAREN HOSKINS WITNESS</u> <u>STATEMENT</u>

LYNNE HUBBARD, by and through her undersigned attorney, pursuant to Florida Statutes § 90.403 and all other applicable law, files this Motion in Limine to Preclude any and all Evidence Regarding the \$5,000 check payable to the Riviera Beach Preparatory Academy, and in support thereof, states as follows:

1. Any and all evidence in connection with the \$5,000 check payable to the Riviera Beach Preparatory Academy, which was referenced in Karen Hoskins witness statement, wherein Bennett stated he saw the check, it was never cashed, a copy was never provided, should be excluded and not admitted into evidence.

2. As any evidence relating to any payment to Riviera Beach Preparatory Academy by a check for \$5,00.00, is irrelevant and the mere mention would be unfairly prejudicial, Respondent seeks an Order in Limine precluding any and all evidence regarding a check for \$5,000.00 made payable to Riviera Beach Preparatory.

3. "Generally, the purpose of a motion in limine is to prevent the introduction of improper evidence, the mere mention of which at trial would be prejudicial." *Buy-Low Save Ctrs., Inc. v. Glinert*, 547 So. 2d 1283, 1284 (Fla. 4th DCA 1989). A motion in limine may not be used as a substitute for a motion for summary judgment but is properly used to exclude irrelevant or improper prejudicial evidence. *See Id.* A party is unfairly prejudiced by evidence when it has a

tendency to suggest a conclusion based on an improper ground. *See State Farm Fla. Ins. Co. v. Figueroa*, 218 So. 3d 886, 889-90 (Fla. 4th DCA 2017).

WHEREFORE, the Respondent, for the aforementioned reasons, respectfully requests this Honorable Court enter an Order in Limine precluding any and all evidence regarding the \$5,000 check and granting such other and further relief as this Court deems just and proper.

RESPONDENT LYNN HUBBARD'S MOTION IN LIMINE TO PRECLUDE ANY AND ALL REFERENCES TO THE ARREST OF SHIRLEY MADISON BROOKS FOR DOMESTIC VIOLENCE

LYNNE HUBBARD, by and through her undersigned attorney, pursuant to Florida Statutes § 90.403 and all other applicable law, files this Motion in Limine to Preclude any and all reference to the arrest of Shirley Madison Brooks for domestic violence, and in support thereof, states as follows:

1. Shirley Madison Brooks domestic violence arrest was a "No File" and the no contact order was rescinded. See copies of the Palm Beach County Clerk Court Docket - Case Number 502014MM010017-AXXXMB showing the case was disposed as a "No File" on 7/24/14. Further, it is clear from the police report narrative that Shirley Madison Brooks became involved only in an attempt to break up a fight between the 2 other individuals.

2. Any reference relating to her arrest is therefore irrelevant and the mere mention would be unfairly prejudicial, and only meant to humiliate and harass the witness. ...its probative value is substantially outweighed by the danger of unfair prejudice, confusion of issues, misleading the jury, or needless presentation of cumulative evidence.

3. Therefore, any and all references to the arrest of Shirley Madison Brooks for domestic violence, should be excluded and not admitted into evidence.

4. Respondent seeks an Order in Limine precluding any and all evidence regarding the same.
